Eligibility

Concession is available on Certificate I - IV courses only, for students who meet the eligibility criteria for the government Victorian Skills First funding program, and ALSO hold one of the following:

- Commonwealth Health Care card
- Pensioner Concession card
- Any dependent spouse or dependent child of one of the above cardholders
- Veterans Gold card.



Concession holders who meet the specific requirements, will pay 20% of the published standard Tuition Contribution Fees.

In order to claim a concession on tuition fees for Certificate I - IV courses, we are required to validate your concession card. This can be done by you providing your Customer Reference Number (CRN) and card expiry date as part of your course application. Alternatively you can present your card in person. Concession will apply to each enrolment whilst our records of your concession entitlement are current. Once this is no longer current, you will be required to provide updated details, including a new expiry date, of your concession entitlement in order for concession to be applied to future enrolments.

If a concession card is validated or presented after course commencement, it can only be applied to any units of study not yet commenced. Concession must be presented for each new course commencement.

If you are unable to provide your CRN and expiry date or present a concession card, the standard Government funded fees level will apply for eligible candidates. Students who do not meet the eligibility criteria for Victorian Skills First funding, will be charged the Fee for Service rate.

Students who identify as Indigenous when applying and who also meet the eligibility criteria for the Victorian Skills First funding program, will receive concession on Certificate I - IV, as well as Diploma and Advanced Diploma level courses. Asylum Seekers and trafficked persons referred to The Gordon, will automatically be eligible for concession if they also meet the eligibility criteria for the Victorian Skills First funding program.

IMPORTANT: A concession does not apply for students enrolling into a Diploma or Advanced Diploma unless the student is Indigenous and meets all the eligibility criteria.

Maximum gross income to qualify for a Health Care card

To qualify for a Low Income Health Care card your income must be below the limit that applies to you for the 8 week period ending on the day you lodge your claim.

Single, no children	\$757	\$6,056
Couple (combined), no children	\$1,295	\$10,360
Single, one dependent child	\$1,295	\$10,360
Couple (combined), one dependent child	\$1,329	\$10,632
For each additional child, add	\$34	\$272

Apply now!

1. If you think you may be entitled to a Health Care card, please apply as soon as possible.
2. Low Income (LI) Health Care card eligibility is assessed on your income level 8 weeks prior to application.
3. If you have provided all the required information, assessment can take up to 28 days, however you may be able to obtain a temporary card.
4. Please ensure you apply early! Students will be required to produce their Health Care card prior to the commencement of their course and failure to do so may result in full fees being payable. The current Health Care card start date must be before the student's course commencement date.
